Dispur the 6<sup>th</sup> October, 2009. The selected candidate mentioned above will have to submit an undertaking to that effect at the time of joining Judicial Academy, Assam.

He will be on probation for a period of 1 (one) year with effect from the date of his joining. He is directed to join his duties within 15 (fifteen) days from the date of receipt of the order.
