*"The bidder should have average Annual Turnover of at least **Rs.50,00,000/- (Rupees Fifty Lakhs only)** in the last 3 (three) Financial Years."*

#### **Instead of**

*"The bidder should have an Annual Turnover of at least Rs.20,00,000/- (Rupees Twenty Lakhs only) in each of the last 3 (three) Financial Years."*

#### **11. shall be read as:**

*"The Price Bid should contain only the price quotation of all the aforesaid items inclusive of all taxes and other charges i.e. **Testing, Installation of equipment, laying charge, wiring, commissioning, other accessories, etc.**"*

#### **Instead of**

*"The Price Bid should contain only the price quotation of all the aforesaid items inclusive of all taxes and other charges i.e. Testing, Installation of equipment, Wiring, etc."*
