- (c) The envelope must include sealed and signed copy of the Short Notice Inviting Quotation as acceptance of the Terms and Conditions mentioned therein.

02 AMC Period :

The AMC period for the contract will be 12 months, with a provision for extension up to another 12 months keeping the rates and terms & conditions of the contract unchanged, subject to satisfactory performance and discretion of Judicial Academy, Assam.

03 Performance and Bank Guarantee (PBG) :

The bidder shall be required to furnish a PBG equivalent to 5 % of the total order value valid up to 03 months beyond expiry of ANNUAL MAINTENANCE CONTRACT period of 12 months. The PBG shall be furnished before the start of the AMC failing which amount equivalent to the 5% PBG value shall be held.

04 Termination of Contract :
